It is our pleasure to be of service to you. Our vehicles are kept in top condition by our staff, and it is of utmost importance that all occupants act in a responsible manner to preserve the condition of the vehicles. On behalf of the occupants and/or company, the authorized signer of this document is fully responsible for the charter(s) of *Premiere #1 Limousine's* vehicle(s) as stated herein.

Deposits

A deposit equal to 20% of the total estimated charge for the trip is required. Trips scheduled 7 days or less from the travel date will be charged in full at time of reservation. Deposits are subject to the following forfeiture provisions:

- The initial deposit of 20% of the total estimated charge is non-refundable.

Final Payments

- Due one week prior to reservation date if paying by check or cash.
- If the deposit is made with a credit or debit card, the final amount due will be charged one day prior to the reservation date using the same card unless notified in advance.
- Sunday and Monday reservations will be charged on the Friday prior to the reservation date.

Damages

Charges for damages per incident include the following:

- Stains \$35.00
- Decanter \$100.00
- Glassware \$10.00
- Vomit/Sickness \$250.00
- Smoking \$250.00
- Audio/Visual Equipment \$200.00

Cleaning things such as spilled drinks, food and/or carpeting may result in additional charges. The fore mentioned damages are minimum amounts and could increase depending upon the amount of damage. For these, or any other damages, the authorized signer agrees to pay for the cost of the damages/replacements. In the event that the terms and conditions stated herein are not complied with, the authorized signer does hereby grant permission for *Premiere #1 Limousine* to apply charges to the accompanying credit card.

Overtime

Overtime will be charged to the credit card or debit card on file at the appropriate vehicle hourly rate in 30

minute increments or fraction thereof.

Beverages

Premiere #1 Limousine will supply bottled water. Additional beverages (non-alcoholic) can be supplied by the client. The client may either drop them off at our location before the scheduled transportation or bring them along at the time of pick up. *Premiere #1 Limousine* and/or driver(s) cannot buy alcoholic beverages for our client(s). Only alcoholic beverages purchased on the tour are allowed to be consumed inside the vehicle during the tour.

Conditions

The Pennsylvania Liquor Code makes it illegal for a licensee, employee, or any other person to serve or sell alcoholic beverages to visibly intoxicated persons. Some common signs of visibly intoxicated persons are loud speech, boasting, crude behavior, drinking too fast, slurred speech, and stumbling. If any individual in your group is determined to be visibly intoxicated, service of alcoholic beverages by the wineries and/or breweries will be stopped immediately and no tasting fees or refunds will be issued for the entire group. If time remains on your rental, we can continue to use up this time however you like, with the exception of visiting additional wineries and/or breweries.

Premiere #1 Limousine and its representative(s) and/or driver(s) assume no responsibility for any articles left in the vehicle at any time. The driver may terminate the charter without refund should he/she deem the occupant(s) unruly or in violation of safe vehicle operation. *Premiere #1 Limousine* and its representative(s) and/or driver(s) assume no responsibility for illegal acts of the occupants during the charter. *Premiere #1 Limousine* cannot be held responsible for delays or inconveniences due to traffic, unknown/unseen mechanical failures and/or situations deemed an 'Act of God'. The signer assumes full, financial responsibility for any damages to the vehicle or property caused by occupants, whether by accident, neglect or intent. Smoking is not permitted in the vehicle. The signer assumes responsibility for any additional charges not included in the price.
